02. METHOD OF SUBMISSION OF TENDER:

Tender should be submitted through GOK Procurement Portal https://eproc.karnataka.gov.in in two parts.

Tender shall be submitted in two parts as under:

- a) Technical Bid
- b) Financial Bid

a) TECHNICAL BID:

The Technical Bid should contain:

i) The details of the Tenderer in **Annexure** "A"

ii) Earnest Money Deposit:

- **a)** The EMD in Rs.50,000/- shall be credited to the account of Centre for e-procurement through (a) credit card (b) Debit card (c) National Electronic Fund Transfer (N E F T) (d) Remittance over the counter (O.T.C.) The Manufacturer bid will be evaluated only on confirmation of receipt of the payment (EMD) in the GOK's Central Pooling A/c.
- **b)** Earnest Money Deposit submitted by the tenderer /s will not carry any interest.
- **c)** Earnest Money Deposit of unsuccessful tenderer /s shall be returned within 30 days from the date of finalization of the tender.
- **d)** Earnest Money Deposit of the successful tenderer / s shall be returned by the Corporation only after satisfactory completion of the supplies in respect of the orders placed under tender.
- **e)** Test Reports from reputed Testing Laboratories for all technical parameters shall be submitted for chemicals.

f) Random samples of **DYES & CHEMICALS in each item** will be drawn from each consignment after receipt of the same at our Units by the KHDC officials of Quality Control Department, and the **DYES & CHEMICALS** will be tested for its parameters and on the basis of the Quality Test Report, material will be accepted. If not conforms to our PO parameters, entire material will be rejected and returned to suppliers at their cost & risk.

3) FINANCIAL BID

- **b)** No correspondence will be entertained once the tender has been submitted in response to the tender notice.

5) OPENING & SELECTION OF TENDERS:-

a) Technical bids will be opened by the Corporation in the presence of tenderers who wishes to be present at **11.30AM on 2-6-2017**. The Financial Bids will be opened after technical evaluation of Test reports.

b) CHEMICALS test reports are to be submitted with the Technical bid.

- c) The financial bids would be opened at a later date only of those tenderers who are successful in the technical bid, i.e., of only those reports which are found technically suitable for further evaluation. **Testing charges for all samples** drawn before and after supplies should be borne by the tenderer.
- **d)** Orders will be placed on one or more tenderers considering quantity, price and delivery schedule.
- **e)** The Corporation reserves the right to call all the qualified tenderers who have participated in this Tender for Negotiations and finalization of rates and terms for **DYES & CHEMICALS** requirements.

6. VALIDITY OF THE OFFER AND DELIVERY SCHEDULE:

Offer shall be valid for a minimum period of three months from the date of opening the tender and rates tendered should be firm throughout the contractual period. Deliveries should be executed fully as indicated in the purchase orders

which are issued from time to time over a period of three months from the date of opening of price bid. The delivery schedule may be postponed or preponed depending upon the requirement of the production units. There will be no changes in the terms of contract. The Corporation reserves the right to call all the eligible tenderers for negotiation of rates, terms of supply and delivery schedule whenever necessary.

7. TERMS OF SUPPLY:

- **a)** Orders will be placed on one or more tenderers whose tenders are accepted, at the discretion of the Corporation, subject to compliance with the terms and conditions regarding commitment of quantity, delivery schedule of tenderers against requirement of the Corporation.
- **b)** Delivery schedule will be indicated in the purchase orders.
- **c)** Random samples of **DYES & CHEMICALS** of each lot will be drawn by the quality control department for testing purpose, in case of any variations found in quality parameters, entire material will be rejected and returned to suppliers at their cost and risk.
- **d)** Successful tenderer shall supply DYES & CHEMICALS as per the schedule mentioned in the purchase order. Failure to supply as per schedule, tenderer will pay liquidated damages at 1/2% per week on the value of such undelivered material till completion of supply. This clause is applicable for all items. However, penalty clause shall not be applicable in case of delay in release of payment by KHDC Ltd.
- **e)** Part of a week will be treated as full week. For purpose of calculation of liquidated damages, date of receipt of consignment at FOR Priyadarshini Textile Process House, Peenya, Bangalore will be taken into account. Details of recovery of liquidated damages will be furnished by the Accounts department, KHDC Ltd, Bangalore to the concerned supplier on request.
- f) In the event of supplies made after the delivery dates mentioned in our Purchase Orders/ delay in replacement of rejected MATERIAL if any before the delivery date mentioned in the purchase orders, the corporation has the right to accept such quantities of MATERIAL based on the requirements taking into consideration the prevailing rate of SUCH MATERIAL on the date of supply or at the Purchase order rate whichever is lower.
- **g)** Corporation shall have the right to recover any loss that it may sustain consequent to any breach on the part of the tenderer/s to fulfill the terms of contract including failure to supply partially or in full/irregular supplies, out of EMD.
- **h)** For shortages in weight/Length, value of the short supplies and proportionate taxes will be recovered from bills.
